2. Project Background and Description

DMRA proposes to build the Northeast Sportsman Complex located at 1203 Harbin Hill Road in Mountain City, Tennessee. The project will create rifle, pistol, shotgun, and archery shooting ranges and an indoor Sportsman Center that would be used for education, programs and events; parking areas, access road; restrooms; and outdoor educational facilities.

The U.S. Fish & Wildlife Service, Wildlife and Sport Fish Restoration Program (WSFR) works with states to conserve, protect, and enhance fish, wildlife, their habitats, and the hunting, sport fishing and recreational boating opportunities. The Division of Wildlife and Sport Fish Restoration Program provides oversight and/or administrative support for grant programs, including the Wildlife Restoration Grant Program and the Basic Hunter Education Program. Spending for the Hunter Education Program is authorized in the Wildlife Restoration Act. The Hunter Education Program provides grant funds to the state fish and wildlife agencies for projects to provide instruction in firearm operations and safety,

wildlife management, nature conservation, ethics, game laws, outdoor survival and wilderness first aid. Funds may also be used for the development and operations of archery and shooting range facilities.

The goal is to teach students to be safe, responsible, conservation-minded hunters. Most States, including Tennessee, require completion of a hunter education course prior to purchasing a hunting license.

The purpose of the proposed Doe Mountain Sportsman Complex project is to provide a place for wildlife education and expand and increase shooting opportunities and safe firearm education for the public, resulting in safe hunting and shooting experiences in the northeast Tennessee area.

The need for the project is due to a shortage of available public ranges particularly in East Tennessee. Greeneville, is the closest Hunter Education Safety Facility serving East Tennessee and is 92 miles southwest of Mountain City and the TWRA/John Sevier Range in Knoxville, located over 156 miles southwest of Mountain City. There is a need to provide the public with structured and safe hunting, shooting, and archery opportunities, as well as, youth recruitment and hunter education and firearms safety in order to preserve the rich hunting and gun heritage in Tennessee.

Location map, carbon plots, and survey are included in Appendices.

The proposed project goals are to include the following:

- 1. Develop a 50-to-75-yard pistol range with 8 to 10 stations
- 2. Develop a 100-to-300-yard rifle range with 4 to 6 stations
- 3. Develop a Sporting Clay course with 2 to 3 stations
- 4. Develop a 3-D archery courses with 40 stations
- 5. Develop a Skeet and Trap Combo Range with 2-3 stations
- 6. Develop a Stand/Flurry Range with 2-3 stations
- 7. Develop a Tactical Range with 6 stations
- 8. Develop an outdoor classroom pavilion
- 9. Develop a Sportsman Complex with a training facility: check-in area, classroom, interior bathrooms, exterior bathrooms, kitchen, and ammo storage
- 10. Develop access roads, trails, parking areas and bathrooms to serve the public

Doe Mountain Recreation Area is enrolled in a 40-year, revenue-generating, forest carbon storage program that commenced in 2019. There are nearly 100 permanent forest monitoring plots across the property, some of which overlap the Northeast Sportsman Complex (see map in Appendix A). The plots are used to measure the mountain's tree growth and also determine the amount of carbon offset revenue available to the DMRA. Carbon revenue decreases or, in some cases, must be repaid, if the DMRA's activities do not result in more stored carbon in the property's trees than is released into the atmosphere via timber cutting. To that end, successful applicants will demonstrate how the carbon monitoring plots will be addressed and avoided to the greatest extent possible.

The Project shall be designed and built in accordance with all governing bodies and their recognized codes including, but not limited to, the Mountain City Building Department, the Mountain City Fire Department, National Fire Protection Agency (NFPA), American with Disabilities Act (ADA), International Energy Conservation Code, National Institute for Occupational Safety and Health (NIOSH), Occupational

Safety and Health Administration (OSHA), Environmental Protection Agency (EPA) and any other federal and state agencies relative to building requirement or health regulations.

DMRA has chosen the Design-Bid-Build method of delivery and needs to maximize the value of the established budget for the Work. Architectural and Engineering (A&E) services shall assist DMRA in refining their budget for the Range. The A&E shall be responsible for all disciplines required to design, engineer, estimate, and perform construction administration for the Project in accordance with all governing codes and requirements. The A&E's compensation for design and preconstruction Work will be subject to a Not-to-Exceed amount and paid on hourly rates. Upon completion of Pre-Final Design Documents, A&E shall present a construction estimate proposal to DMRA, which DMRA intends to use to propose funds for the Project. Subsequent to approval by DMRA Board, the AE shall assist DMRA in securing a General Contractor for the project.

The Project Site is owned by DMRA and located southwest of Mountain City in Johnson County, Tennessee. The designated site is approximately 215 acres with an estimated 70 acres that will contain the construction area. See (Appendices for Location Map and Survey). A residential area borders the property to the north and west while open space and undeveloped land occupies the to the north, east, and south. The Range shall be designed and constructed in a manner that will minimally impact the residential occupants adjacent to the site, specifically noise pollution. A&E shall be responsible for providing geotechnical information relative to the range development.

Weight (Points): 10 (10% of Total)

4. Proposer Response




APPENDIX A: Location Map
